APPI - CIP COMPARATIVE VALUES

What is the value of my APPI membership?

With APPI membership, you are part of a profession regulated by the Province of Alberta (Alberta Professional Planner Regulation). This means that you:

- have the exclusive right to use the protected title Registered Professional Planner (RPP)
- are accountable to the public interest through the APPI Code of Professional Conduct
- commit to continuous professional learning
- are mobile, as a regulated member, to work across Canada

To comply with our collective requirements in the Alberta Professional Planner Regulation and our responsibility to the public interest, your APPI membership means that you:

- have opportunities to contribute to and benefit from APPI efforts to monitor issues and legislation related to planning, and enhance the public and government's planning knowledge
- are covered by the APPI Professional Liability Insurance Program (which will replace the PLI program currently offered through the CIP)
- participate in the APPI Continuous Professional Learning Program and will have access to the APPI Continuous Professional Learning Program (which will be administered via the APPI website in the future)
- have representation on the Professional Standards Committee (PSC) and the Joint Administrators Group (JAG)
- receive regular communications via E News, Bulletins, Press Releases and Council Candour
- receive PLAN North West
- organize and have access to regional events, WTPD events and education sessions
- are invited to attend APPI's annual conference
- celebrate and participate in APPI members' accomplishments through the APPI Awards for Planning Excellence and Merit, and individual APPI Awards
- are part of the network of professional planners across Alberta, the Northwest Territories and Nunavut, and can share in the collective expertise and experiences of our broad community
- receive opportunities to volunteer as APPI representatives with external planning related organizations and committees (e.g., Calgary Planning Commission, Edmonton Urban Design Panel, University of Calgary Faculty of Environmental Design (EVDS) Faculty Council)

What is the value of my CIP membership? (Provided by CIP)

Since 1919, membership in the Canadian Institute of Planners (CIP) has exemplified an individual's commitment to the planning profession and planning best practices. CIP advocates for planners nationally and internationally, and provides membership services that help planners advance in their careers. Membership with CIP also provides opportunities for networking and knowledge transfer.

Does ceasing to be member of CIP restrict my ability to practice planning anywhere in Canada?

The *Canadian Free Trade Agreement* (CFTA) came into effect on July 1, 2017. Alberta's labour mobility obligations under the CFTA require Alberta and all provinces' and territories' professional regulatory organizations to recognize, upon application, workers who have been certified for an occupation by a regulatory authority in another province or territory, as qualified to practice that occupation in Alberta. Recognition is required to be granted expeditiously without further material requirements for training, experience, examinations or assessments unless a labour mobility exception has been approved.

However, in order for a member of APPI to practice planning in a jurisdiction outside of APPI and use the restricted RPP title, they must register as a Non Resident member of that respective Provincial and Territorial Institute and Association (PTIA). The title denotes rights and responsibilities of regulated members and the PTIA's can only regulate those RPP's who are their own members.
