



We often adopt policy and regulatory changes that we hope will theoretically encourage more infill development in our communities. However, this planning-focused approach doesn't fully realize the necessary preconditions that would facilitate meaningful increases in infill development. In our work, we have witnessed the following themes emerge: Affordability – Municipalities are encouraging infill development to increase housing supply in response to affordability pressures. Infrastructure Requirements - Blanket infill approaches often neglect proactive infrastructure improvement strategies that manage risk. Collaboration + Engagement – We are seeing municipalities shift the focus of their engagement from individual applications to broader neighbourhood change. LU = 1.25

As a new growth management board established in 2018, the Calgary Metropolitan Region Board (CMRB) had the monumental task of building an organization AND creating a regional growth plan to improve quality of life for residents and businesses. To find a path through innumerable perspectives and unknowable futures, the CMRB planning process established a baseline understanding of the region and focused on the benefits of regional planning – what do we want to achieve? The regional growth plan does not imagine an ideal end state in the form of a land use plan; rather, it establishes a mandatory framework, a form of contract, that focuses on where regional planning and collaboration create the greatest benefits. This approach to establishing a common purpose and a pathway to tangible and measurable outcomes has led to success, even in the Growth Plan's first year post approval! This in-person engagement will walk participants through how we developed a work plan focused on benefits, the role of datasets and background reports, scenario planning, and the importance of measurable and continual improvement to create change, even in uncertain times IU = 1.25

Natural disasters such as floods can cause immense destruction, affecting communities, their economy, and daily lives. The Town of High River is a model of resilience in the face of such disasters. This session aims to showcase High River's resilience and how it has navigated an uncertain future. The experience and lessons learned in flood protection and mitigation, annual river monitoring, and flood preparedness will be shared in this session. The four stages of local river monitoring and updates that inform residents of potential risks will be explained. A deeper understanding of how to prepare for and respond to flood emergencies will be gained by attendees. An unconventional approach to planning, focusing on community engagement and crossdisciplinary collaborations, will also be discussed. The meticulous efforts have resulted in world-class protection and made High River one of the safest communities in Canada. Since many communities in Alberta are located along major rivers, by attending this session, attendees will learn about innovative planning strategies and community engagement approaches that can help them navigate an uncertain future involving floods. They will also gain practical solutions and insights into how to tackle the rising environmental challenges facing planners today. LU = 1.0

### **2A** Shifting Priorities: Remote Work & Land Use Planning MARY SCHAFFER

As the world shifts into a "new normal", remote working options aren't going anywhere. With this comes a myriad of opportunities, like better work life balance, flexibility, and reduced overhead. But what does this mean for the future of planning? Downtown urban cores are not seeing the massive influx of workers arriving back to them as was predicted. Instead, vacancy rates are high, and the perception of safety is in many cases shattered. Meanwhile, rural communities struggle to provide housing choice and options for remote workers moving out of busy urban areas. This session will focus on the impact that remote working has on land use planning now, and in the future.

Planning is slow to pivot and adapt to changing externalities. He will share recent studies into this area of research and lessons learned to explore where land use trends are going – and importantly – how to shift with them. And will thread the needle in a local context and explore how to better change with these pressures.

Remote working is here to stay. Planners need to understand the implications of this on land use planning and work to capture the positive implications while navigating shifting priorities. LU = 1.25



# **2B** Unveiling the Value of Spatial Land Use IDA

Communities throughout the world are facing ever-growing challenges such as climate change, housing affordability, the ageing population, and more. These challenges are increasing expectations of the role of planners as enablers of socially, economically, and environmentally thriving communities. The solution to many of these challenges will require accurate, timely and location-ready data that can be analyzed to generate insights for timely and evidence-based planning. In the aftermath of the 2016 Horse River wildfire, faced with the challenge of rebuilding and addressing the impact of the region's changing economy on its longrange planning, the Planning and Development Department of the Regional Municipality of Wood Buffalo conducted its first inventory of land use in the region. In 2022-23, the land use inventory was updated with approved Development Permits from 2016 onwards using FME, a powerful spatial data processing tool. This land use inventory generated a comprehensive dataset of current land use that accurately represents the actual conditions in the region. Evaluating the existing land use patterns, densities, and relationships helps determine future generalized development concepts and land available to meet the region's future land use needs. Creating this land use inventory required tremendous efforts and overcoming many challenges. IU = 1.25

Over the last two years, O2 and the City of Lacombe have collaborated to revive a decadeold downtown plan—without revising the plan itself. Their process was anchored by a committee of community leaders and supported by purposeful facilitation and design. In a short time, they have successfully delivered on a range of implementation measures, including new landmark elements, greenspace upgrades, an updated downtown visual identity, and a fullblock plaza conversion.

This session will tell the story of how the collaboration grew, showcase some of its award-winning outcomes, and map out a series of insightful and transferrable lessons, including:

- tips for working with aging plans.
- strategies for involving the community in capital prioritization.
- establishing appropriate administrative leads to drive the process.
- enabling elegant transfer processes from concept to construction.

Planners who oversee good but dusty plans, or who are working with clients that own good but dusty plans, will benefit from this interactive hour. Following the presentation, a facilitated discussion promises to prompt broader conversations about the increasing demands for implementation within local plans, steering through the uncertainties of implementation, and the powerful role communities can play in owning and guiding the application of plans in their neighbourhoods.
