

# **Important Notes about APPI President Elect Nominations:**

- 1. To be eligible for nomination as President Elect, the member must be a Registered Professional Planner (RPP) member.
- 2. Nominees must be RPP members of APPI "in good standing". "In good standing" means member fees for the current year are fully paid and all requirements for the maintenance of membership are satisfied.
- 3. Nominees for President Elect should have previous experience on APPI Council, possess strong leadership skills, be confident public speaking and have a high level of discretion, political acumen and relationship building skills. Please familiarize yourself with the APPI President Elect responsibilities and qualifications document.
- 4. Nomination forms must be submitted to the APPI Office on or before **February 27, 2020** and may be submitted by email to <a href="mailto:admin@albertaplanners.com">admin@albertaplanners.com</a>, attention APPI Nominating Committee.
