Primary duties include:

- Participate in internal and external meetings, conduct research, respond to ad-hoc requests, support leadership and senior staff, and provide advice on a range of climate-oriented initiatives.
- Provide climate-focused expertise in response to current planning applications.
- Support the implementation climate actions identified in the Calgary Climate Strategy and Calgary Climate Strategy Implementation Plan.
- Support development of planning bylaws, policies and guidelines to advance The City of Calgary climate objectives.
- Support the implementation of the Growth and Development Climate Framework.

### Qualifications

- A degree in Planning that is recognized by the Canadian Institute of Planners (CIP) and at least 3 years of relevant planning experience, OR;
- A degree in a planning related discipline and at least 4 years of relevant planning experience.
- Membership with the Alberta Professional Planners Institute (APPI) would be considered an asset.
- Experience in project management, urban environment, developing climate policy, integration of climate into city planning approvals processes, land development and presenting to external participants (citizens, industry, and approving authorities) will be considered assets.
- Proven research skills with particular focus on Climate Change and Urban Planning interface.
- Proven communications experience with excellent customer service skills and a demonstrated ability to build beneficial relationships, facilitate conflict resolution, and contribute to team goals.
- Success in this role requires strong strategic and analytical thinking with a focus on change management.
