



## Planning Positions with Rocky View County

Rocky View County's Planning department is growing. Our new and enthusiastic team is working on a number of exciting projects, including the preparation of amendments to our Municipal Development Plan and Land Use Bylaw. We encourage a collaborative and supportive environment for staff to grow within the department and focus on their interests. Spread across over a million acres and with a diverse range of communities, the County is an amazing place to develop your Planning career.

### Regional Planning Strategist (Permanent)

With the recent approval of the Calgary Metropolitan Region Growth Plan, the County will continue to collaborate with our neighbours on regional planning matters. The Regional Planning Strategist role will support the Planning Manager and wider department as we contribute towards the development of Joint Planning Area Context Studies and other projects that are part of the Calgary Metropolitan Region Board's five-year strategic plan.

In addition to this core responsibility, the position offers the opportunity to participate in the project to amend the County's Municipal Development Plan, and to support the Planning Policy team in drafting area structure plans. The position will also be responsible for project managing the implementation of several Planning initiatives arising from Council's strategic objectives.

### Planner (Permanent) (Planner 1, Planner 2, Senior)

This permanent position is placed within our Planning and Development team, which is focused on processing a diverse mix of conceptual scheme, land use amendment and subdivision applications. The role is fast-paced, with the small team of eight Planners processing over 200 files per year, and it offers the opportunity to present frequently to Council and to other boards and committees. Strong collaboration with developers, landowners and residents is an important element of this role. Further responsibilities include assisting on the Land Use Bylaw amendment project which will be undertaken over the next year and supporting applicants through the subdivision endorsement process.

The County is considering candidates with varying experience levels for this role from the junior Planner 1 to the Senior Planner position and will place the successful applicant based on experience and qualifications.

### Planning Assistants (2-year terms) (3 positions available)

We are looking to add to our front-line team with these new three positions handling a significant volume of customer enquiries. The County has taken over 6,000 Planning enquiries in-person or over the phone in previous years and the wider Development team has processed approximately 450 development permits each year.
