Reporting to the Manager of Planning and Development, this position provides technical leadership, expert advice, and guidance to both staff and stakeholders. You will oversee the administration, review, and enforcement of the LUB while driving special projects that influence the City's built environment.

This is an exciting opportunity for an experienced planner who wants to:

- Lead high-visibility, impactful development projects.
- Shape policy, planning tools, and the interpretation of municipal bylaws.
- Collaborate with colleagues, developers, Council, and the public.

## What will you do?

As Senior Development Planner, you will:

- Lead and manage complex development applications, including approvals, conditions, and enforcement for residential, commercial, institutional, and industrial projects.
- Conduct comprehensive reviews and updates of the Land Use Bylaw, drafting policies, regulations, and standards to support sustainable development.

- Experience working with CityView permit processing software (or similar digital permitting software) will be an asset.
